In Person:

1. Visit the local Vital Statistics office in the county where the birth occurred or the Ohio Department of Health's Office of Vital Statistics in Columbus, Ohio.
2. Complete the Application for Certified Copies form available at the office.
3. Present a valid government-issued photo ID.



4. Pay the fee using cash, check, money order, or credit/debit card (payment options may vary by location).

5. Receive the birth certificate, typically on the same day.

Via Phone:

1. Call the VitalChek Network, an authorized service provider, at 1-877-648-0605.

2. Follow the instructions provided by the automated system or a customer service representative to complete the application process.

3. Provide the necessary information and a valid government-issued photo ID number.

4. Pay the applicable fee with a credit or debit card.

5. The birth certificate will be mailed to you.

Fees and Processing Times:

The standard fee for a certified copy of a birth certificate in Ohio is subject to change, so it is advisable to check the current fee on the Ohio Department of Health's website or by contacting the Office of Vital Statistics.

Processing times can vary.

Step 5: Pay the Replacement Fee



There is a fee for replacing an ID or driver's license. Be prepared to pay the fee at the time of application. The BMV accepts various forms of payment, including cash, check, money order, and credit/debit cards. The exact fee can be found on the Ohio BMV website or by contacting the BMV directly.

Step 6: Have a New Photo Taken (if applicable)

For a replacement driver's license or ID, you will likely be required to have a new photo taken at the BMV office.

The process for License reinstatement
